INTERNATIONAL PARTNERING INSTITUTE EXCELLENCE IN PARTNERING FACILITATION AWARD

PURPOSE

The Excellence in Partnering Facilitation Award honors an outstanding facilitator who has embraced the International Partnering Institute's (IPI) partnering model and tools as well as our mission to develop high trust relationships and partnered organizational cultures.

BACKGROUND

IPI is a 501(c) 3 non-profit charitable organization. IPI conducts research to capture partnering concepts and techniques that develop high trust relationships and organizational cultures for the delivery of construction projects and provides education and certification in those concepts and techniques. IPI is funded by revenue generated from member contributions, seminars, and educational resources.

IPI's Excellence in Partnering Facilitation Award is designed to recognize an individual who has successfully led teams in the implementation of IPI's Collaborative Partnering best practices, at the project, program and/or strategic levels. The recipient will also have contributed to the profession of Partnering through academic contributions and/or articles on Partnering and will have grown the profession by training other individuals on the practice of Partnering.

PARTNERING DEFINITION

Partnering is defined as "a formal process of collaborative teamwork to achieve measurable results through agreements and productive working relationships."

AWARD WINNERS

In addition to being honored at the IPI Annual Awards Ceremony, winners will:

- Be recognized as the top facilitator of the year and a leader in Partnering excellence
- Join an elite network of peers in the industry committed to Partnering excellence
- Use their organizational success to contribute to the growing body of knowledge of what makes Partnering work

ELIGIBILITY REQUIREMENTS

- One application per submittal
- Candidates may be nominated by an Owner, Designer, Contractor, Construction Manager, or Facilitator
- Minimum 2 Letters of Recommendation: Please provide a brief letter of recommendation from at least one Contractor and one Owner Representative describing the Facilitator's impact on individual projects and/or strategic partnerships

AWARD PROGRAM GUIDELINES

Award Process

The IPI Awards process is led by the IPI Awards Committee, volunteers from all walks of the construction industry with in-depth understanding of construction Partnering. The Awards Committee establishes the standards for award winning projects, reviews the awards applications and determines the level of recognition awarded to applicants.

Award recipients are recognized each year at the annual IPI Awards Ceremony.

The steps of the process include:

1. Review submittals for eligibility and adherence to the guidelines.
2. Judges' review of written award submittals against the criteria.
3. Selection of finalists for the award.
4. Verification/clarification of recipient information and results.
5. Judges final recommendations for award recipients.
6. Presentation at the IPI Awards Ceremony.

How Winners are selected

Applicants are expected to complete the nominator/nominee form (page 4) and address the evaluation criteria (page 5) in a **5-page** (maximum) attachment.

Attachments, photos and/or exhibits that demonstrate the facilitator's implementation and/or commitment to a partnering culture change process are unlimited and are not counted towards the 5-page write-up.

Judges will look carefully at the responses given against the criteria established and not the sophistication of the package submitted. The judges will then determine which applicant will be recognized. This prestigious award will be presented only in those years that a deserving facilitator is nominated.

APPLICATION TIPS

- Pictures and diagrams are great! Keep in mind the pictures must be supported by the write-up you provide.
- Start your preparation early, complete it, then go back and give it a review to brush-it-up.
- Have your partners look over the materials you prepare for additional comment or insights.
- Make sure you get your application in by the deadline.
- A panel of judges who may have no previous exposure to your organization will review and evaluate your write-up. The judging panel for the Excellence in Partnering Facilitation Award is made up of experienced and qualified professionals. They can only evaluate what you present.

Address the following criteria in the **5-page** (maximum) write-up:

- Describe the facilitator's unique approach/style of facilitation and how it contributed to the successful partnering of projects
- Evidence of professional neutral facilitation resulting in successful projects/programs/strategies
- Evidence of how the facilitator used the IPI working model/tools in their facilitations
- Demonstrate evidence of skill level and commitment to partnering
- What makes this facilitator stand out as an example of excellence in partnering facilitation?

And please attach the Letters of Recommendation in attachments section (letters are not counted against the 5-page maximum).

SUBMITTAL INFORMATION

Submit an electronic copy (PDF) via email to the email address identified on the front of the application package by the deadline.

Format for Submittal:

- Font size of 12 pt. Arial with half inch margins; 1.5 spacing.
- A cover sheet with a photo or graphic may be used.
- A dividing page separating sections is encouraged and will not count against the maximum number of pages.

Applicants will be billed for the application fee plus any additional donation they would like to add. Payments may be made by ACH, credit card or check. The payment decision need not be made until the invoice is received.
